### 2. HAZARDS IDENTIFICATION

**Main hazards:** Irritating to eyes.

### 3. COMPOSITION / INFORMATION ON INGREDIENTS

**Hazardous ingredients:** (C9 - C18)PARETH(2 - 18) 0-1%

- (C9 - C18) PARETH(2 - 18) <1%
- 3 - BUTOXYPROPAN - 2 - OL 1-10%
- /-TRISODIUM NITRILOTRIACETATE 1-10%

### 4. FIRST AID MEASURES (SYMPTOMS)

**Skin contact:** There may be irritation and redness at the site of contact.

**Eye contact:** There may be pain and redness. The eyes may water profusely. There may be severe pain. The vision may become blurred. May cause permanent damage.

**Ingestion:** There may be soreness and redness of the mouth and throat. Nausea and stomach pain may occur.

**Inhalation:** There may be irritation of the throat with a feeling of tightness in the chest.

### 4. FIRST AID MEASURES (ACTION)

**Skin contact:** Remove all contaminated clothes and footwear immediately unless stuck to skin. Wash immediately with plenty of soap and water.

**Eye contact:** Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination.

**Ingestion:** Wash out mouth with water. Do not induce vomiting. If conscious, give half a litre of water to drink immediately. Consult a doctor.

**Inhalation: Remove casualty from exposure ensuring one's own safety whilst doing so.**

#### 5. FIRE-FIGHTING MEASURES

**Extinguishing media: Suitable extinguishing media for the surrounding fire should be used. Use water spray to cool containers.**

**Exposure hazards: In combustion emits toxic fumes.**

**Protection of fire-fighters: Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.**

#### 6. ACCIDENTAL RELEASE MEASURES

**Personal precautions: Mark out the contaminated area with signs and prevent access to unauthorised personnel. Do not attempt to take action without suitable protective clothing - see section 8 of SDS. Turn leaking containers leak-side up to prevent the escape of liquid.**

**Environmental precautions: Do not discharge into drains or rivers. Contain the spillage using bunding.**

**Clean-up procedures: Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by an appropriate method.**

**Handling requirements: Avoid direct contact with the substance. Ensure there is sufficient ventilation of the area. Avoid the formation or spread of mists in the air.**

**Storage conditions: Store in cool, well ventilated area. Keep container tightly closed.**
